FINANCIAL RESULTS FOR 2016

We ended 2015 with £215,000 in total in Appeal funds. During 2016 £65,000 was added to that figure, bringing the total raised to just over £280,000. This splendid result was achieved by successful and popular fundraising events and activities, generous donations from members of the village community and over £41,000 from Trusts and Foundations.

2017 FINANCIAL RESULTS TO DATE

2017 has started very positively. Further members of the village community have donated nearly £19,000 to the Appeal including Gift Aid and the PCC has contributed a further £25,000 from its Reserves. In addition, a Trust is contributing £5,000. Together that adds over £49,000 to Appeal funds, taking the total raised as at 31st March 2017 to very nearly £330,000.







UPDATE ON THE DEVELOPMENT PROJECT

The Position in March 2016

As reported at last year's Friends' AGM, tenders for the building works had just been received and reviewed. At that time, minor adjustments were underway in preparation for a submission to the DAC for a "Notification of Advice", which is the approval of the plans and the technical detail on every aspect of the Project that has to be obtained before a Petition for a Faculty can be lodged with the Chancellor.

Progress since March 2016

An application to the DAC was submitted in early May 2016. The approval process turned out to be a far more lengthy and demanding procedure than anyone had expected. Approval was finally received from the DAC in mid December 2016, after further detailed design submissions and technical changes were requested by the DAC. The very long delay was also aggravated by staff sickness at the DAC (there appeared to be no replacement available to progress our application), by a request for additional ecological reports and then a request for us to temporarily remove the reroofing works from the application and carry out an echo bat detection survey in the summer months of 2017.

A Petition for a Faculty was lodged with the Chancellor's office on 24th January 2017. During the public consultation period that followed, a number of letters of objection were sent to the Chancellor. Six of these were subsequently converted into formal, legal objections. As a result, whilst a decision to grant a Faculty still rests with the Chancellor, she may choose to hold a formal hearing before a judge in the church. If this does happen, it will inevitably delay the project further. The PCC will also have to take into account the legal costs that will now arise as a result of the formal legal objections.

Anticipated Programme

It is not clear how long we may now have to wait for the granting of a Faculty, so that we can then proceed with the Project. We hope that might be by the end of June. After allowing for updating the costs as a result of this delay, allowing time for further applications to Trusts and Foundations that will only make a grant once a Faculty has been granted, and a lead-in time that will be required by the contractor, works could begin in September 2017. Completion would then be achieved in May 2018.

The requested bat survey is planned for May/June 2017. If roosting bats are found under the tiles, which is very unlikely to be in more than the two places where tiles are currently missing, only a minor design adjustment will be required to allow them to return to those spots when the roof is replaced. We will need to apply for a new DAC approval for the roof works when the results of the survey are known and then a new Faculty for this work. If all goes to plan, these approvals should be received quickly and it should then be possible to re-integrate the roof works into the main contract.

Costs

There have been further uplifts in cost since last year for the following reasons:

- Closer survey work has revealed a much more extensive schedule of repairs is required than was apparent in the last quinquennial inspection, due to water ingress in three areas through the roof and down the walls, the discovery of asbestos under the floor and in the boiler house and the need to replace the impermeable plaster on the interior walls.
- After reviewing our original proposal to insulate the roof from underneath, we found that this would have introduced a condensation issue. Consequently the proposal has been changed to stripping off the tiles and replacing them over new insulation. Although more expensive, it will enable a much better insulation value to be achieved.
- 3. The validity of the tenders received over a year ago are now well out of time. We continue to have contact with the preferred contractor and are confident at this stage that it will be possible to negotiate a fair contract price when the time comes and which the Development Committee will be able to recommend to the PCC. However, the building market is buoyant at the moment and the cost of materials has increased during the periods of delay.

It is important for everyone to appreciate that the St Andrew's Development Project is, today, very different to that envisaged and approved by the PCC at the time of the Village Appeal Launch in 2014.

Then we were looking to introduce substantial improvements within the existing church building and to add resources and facilities in the new building.

Now, the PCC has decided that its first priority is to bring the church up to a good standard of repair. The second priority is then to undertake the improvements and the third priority to build the extension.

To fail to undertake these important repairs, albeit at a significant additional cost, would be illogical and a false economy.

"Looking at the figures presented at the Friends AGM, I was struck by the level of support for the Development Project from members of the village community; the number of households which have given a donation, the number of villagers who have attended events and the number of villagers who have helped in some way".

"We're not doing this for ourselves but for future generations".
